NOTE: Least number of runs allowed per defensive inning is calculated by taking the total number of runs allowed and dividing it by the total number of defensive innings played, including any partial innings played.

NOTE: In a game where a team wins by mercy rule, the winning team will be credited with seven (7) defensive innings played, while the losing team will only be credited with the number of defensive innings they played.
